

# NSW Independent Liquor & Gaming Authority

## Meeting Outcomes

The Independent Liquor & Gaming Authority (the Authority) held a meeting on 17 September 2025 to consider, among other things, applications under the *Gaming and Liquor Administration Act 2007*, *Liquor Act 2007*, *Gaming Machines Act 2001*, and the *Registered Clubs Act 1976*. The next meeting is scheduled for 15 October 2025.

The Authority considered the following matters, and the status of each matter is listed below.

**Definitions:**

**Not considered** – The matter was not considered by ILGA at this meeting.

**Withdrawn** – The application has been withdrawn.

**Invalid** – The application has been deemed invalid.
