

# NSW Independent Liquor & Gaming Authority

## Meeting Outcomes

The Independent Liquor & Gaming Authority (the Authority) held a meeting on 15 October 2025 to consider, among other things, applications under the *Gaming and Liquor Administration Act 2007*, *Liquor Act 2007*, *Gaming Machines Act 2001*, and the *Registered Clubs Act 1976*. The next meeting is scheduled for 19 November 2025.

An application under the *Gaming and Liquor Administration Act 2007* was also considered out of session.

The Authority considered the following matters, and the status of each matter is listed below.
