Meeting Outcomes

The Independent Liquor & Gaming Authority (the Authority) held a meeting on 22 April 2026 to consider applications and other matters under the *Gaming and Liquor Administration Act 2007*, *Liquor Act 2007*, *Gaming Machines Act 2001*, and the *Registered Clubs Act 1976*. The next meeting is scheduled for 20 May 2026.

Definitions:
